I. BACKGROUND INFORMATION

In 2017, St. Teresa is on her 17<sup>th</sup> year of existence as a Diocese-owned Catholic school though it was founded by Fr. Angelo Insam, an Italian MillHill Missionary. It was opened and continuously managed by the SFIC's, Franciscan Sisters of the Immaculate Conception of the Holy Mother of God since its foundation year in 2000.

With its original mission of educating the girl-child among the Kuria tribe, which comprise the majority of its student's population, this Catholic institution find its support mostly from parents and guardians, the local community, faith-based organizations and related NGOs.

One of these faith-based organizations is the MOKK Stichting originated from the Nederland. The support was channeled through the SFIC-Kenya Mission, hence the partnership of MOKK Stichting and SFIC-Kenya Mission for St. Teresa's. In 2012, the venture was the construction of a 2-level Library building. The building is being utilized as the Office of the Principal, the Staff Room, Conference Room, Audio Visual Room, two (2) classrooms for senior students and the big library. This is an infrastructure development project.

In 2013, the MOKK Stichting- SFIC Kenya Mission partnership moved to Capability building strategy in assisting St. Teresa Kehancha Girl Secondary School through Academic Scholarship Program. Thirty (30) young girls who were both academically qualified as well as belonging to indigent families were assured to finish their high school education until the year 2018.

In 2016, the institution's sustainability was addressed by developing the school's local resources. The school's Integrated and Sustainable Farm was established. Its components are: livestock development, vegetable mass production, fruit trees orchard, forest farming, feeds production for animals' consumption and compost-making. Underscore in this project is the active participation of students as well as some of their parents and the development of farming technology. The project was funded partly by the MOKK Stichting extra money generated from high FOREX rate (Euro – Kenya shillings).

In the Summative Report of 2016, the beginning of the project was reported such as the fencing of the designated area for the Integrated Farm; the building of animal shed to house the cows, goats, sheep; the construction of poultry house for chicken and ducks.

In 2017, this project was expanded both in area coverage and its components. The area covered more than a hectare for this year planted with maize, kales, beans, tomatoes, onions, papaya and banana. This includes the forest trees and fruit trees like mangoes and avocados. Napier grasses were planted also to sustain the livestock of the Integrated and Sustainable Farm of St. Teresa's named "Laudato Si".

Through the "Laudato Si" project, the school compound had maintained its manicured look, as the cows, sheep and goats grazed upon its grass. The school kitchen was supplied with farm produce. Occasionally, chicken, ducks, goats and sheep were slaughtered for the students and staff consumption. Cow's milk was also made available for the staff during tea break. Though these products did not meet the actual needs of the staff and students in terms of required quantity, the farm, somehow reduced the expenses of the school in food. Besides, the



students participation in "Laudato Si" helped them developed their knowledge in agriculture technology and cultivate their love for MOKK Stichting and the school.

The students are normally accompanied by their subject teacher and the Deputy Principal in class exposure like this.





The Geography teacher processed the information gathered by the students and applied the theories learned from the books.

This learning approach help the students not only to retain the classroom lesson on the subject but applied their capacity to analyze a correct theory based on the actual situation.

In other cases, History students are allowed to observe actual court proceedings and discussed their observation in class.

Agriculture students also visited a model farm to learn farming technology from real farmers.



A weekly quizzes in various subjects is also being done to encourage outside the classroom learning among the students. These friendly competition among them strengthened a teamwork between class levels and produced both formal and informal student leaders. As their academic talents and leadership capability recognized, the students showed a positive attitude towards their teachers and the school at large. It is to be noted that the students of St. Teresa's never engaged in any activities against the school in spite of more or less hundreds of cases of school burning in the whole of Kenya in 2017.
